A. Information Given & Idea Expressed

- 1. Theme: Does the poster attract attention, focus your interest on the idea, motivate viewer to take action? Is the message brief and direct?
- 2. Simplicity: Is the poster limited to one main idea and readable from a glance?
- 3. Originality: Does the poster convey an original idea?

B. Art, Design & Lettering

- Pleasing composition, attractive: Is poster well balanced and neatly constructed?
- 2. Dynamic, eye catching, original: Does the poster cause viewers to stop and read it? Is originality used in the design/style of lettering to catch the viewer's attention?
- 3. Neat, easy to read lettering: Is lettering neat and large enough to be read at a reasonable distance? Has standard size poster board (22"x 28") been used?
- 4. Use of Color: Are color combinations pleasing? Are colors used for emphasis?

C. Construction

- 1. Materials: consider texture, shape and size. Are a variety of textures and shapes used?
- D. Works Cited: Are sources of information neatly cited and organized?
